REPRESENTATIVE RESULTS

- **\$3,000,000** – Lawsuit against pharmacy for prescription error that caused brain injury.
- **\$2,700,000** – Malpractice lawsuit against hospital and physicians for failure to diagnose and treat cancer causing patient's death.

- **\$1,415,000** – Malpractice lawsuit against hospital and surgeon as a result of negligently performed weight reduction surgery.
- **\$1,350,000** – Malpractice lawsuit against radiology group and radiologist for failure to diagnose breast cancer.
- **\$1,200,000** – Wrongful Death action against pharmaceutical company involving dangerous medication.
